

GGGI WEBSITE

These terms and conditions govern the use of GGGI's websites, namely, www.gggi.org and any other future websites that may be established by GGGI (collectively the "Site"):

The Site is intended to broaden public awareness of the mission and activities of GGGI, and provide access to data, know how, information, documents and materials (collectively "information") related to green growth. You are welcome to visit the Site, and use the information and communication tools, features and other applications to facilitate and enhance your use of the Site (collectively "tools"). However, your use and access to the Site are subject to these Terms and Conditions, as they may be modified by GGGI from time to time, including any documents expressly included herein by reference (collectively "Terms and Conditions").

By using the Site, you agree to be bound by these Terms and Conditions. Please read these Terms and Conditions carefully. If you do not agree to these Terms and Conditions, you must not access or use the Site.

Access and Use

You may print, download, and store information from the Site for your own convenience and for your personal, non-commercial use, without any right to resell or redistribute them or to compile or create derivative works therefrom, unless with the prior written consent of GGGI.

For certain information, GGGI may provide more specific restrictions and specific terms of use which are hereby incorporated by reference. These specific terms and restrictions are available in the Site where the information is made accessible.

When using the information in the Site, you agree to provide proper attribution to GGGI, including the relevant member country, the individual author of the information, and any third party information provider, in the following format: "The use of this information is with permission from GGGI, subject to the Terms and Conditions in <http://www.gggi.org/terms>." However, you must not implicitly or explicitly represent or suggest participation, endorsement, sponsorship, approval or affiliation by GGGI in the manner and use of the information.

GGGI shall prosecute, to the fullest extent of the law, any use of the information in a manner that falsifies, misrepresents, disparages, or fraudulently uses the information.

Intellectual Property

The Site and all information and tools are owned as the case may be by GGGI, its business partners, service providers, licensors, users or other providers of such information, and are and may be protected by one or more copyright, trademark, patent, and trade secret laws, or other proprietary rights regimes, and international treaties.

Privacy Policy

Generally, you can visit the Site without revealing any personal information. However, in order to access and use certain information or parts of the Site, you may be requested to register and give personal information such as your name, email address, and organization. The personal information you provide will be used only for the purpose for which the disclosure was requested, for example, for technical and customer administration of the Site. Cookies

The Site uses cookies, which are small bits of code stored on your computer and then sent back to the server when you visit the Site at another time. Please note that if you disable the cookies, you may not be able to use certain features of the Site and may be required to re-enter information.

Responsible Use

Any controversy or claim arising out of or relating to these Terms and Conditions or that contests the validity of these Terms and Conditions shall be settled by arbitration in accordance with the United Nations Commission on International Trade (UNCITRAL) Arbitration Rules as at present in force. The appointment authority for such arbitration shall be the London Court of International Arbitration. The number of arbitrators shall be one. The language to be used in the arbitral proceedings shall be English. The Parties agree to be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such dispute. The place of arbitration shall be Seoul, Republic of Korea.

Preservation of Immunities

Nothing in or relating to these terms and conditions shall be construed as a waiver, renunciation or modification by GGGI of any immunities from suit or enforcement measures that it may enjoy under any international and national laws, any agreement between any parties or any international convention or customary international law.

Miscellaneous

GGGI reserves the right to amend these Terms and Conditions at any time, and such amendment will be effective immediately upon posting of the amendment on the Site. Once the amendments are posted, your continued use of the Site will be deemed as acceptance of the modified terms and conditions, so please check these Terms and Conditions from time to time.

GGGI reserves the exclusive right, at its sole discretion, to alter, limit, or deny any user access to the Sites or any portion, thereof, or discontinue the Site, permanently or temporarily, without notice.
