Provisional Dates for the 2020 Sessions of Governance Organs

1. This document outlines the provisional dates and locations of the 2020 sessions of the Assembly, Council, and the Management and Program Sub-Committee (MPSC), in order to support the effective engagement of Members.

Dates and Locations

2. The following dates and locations are proposed for the sessions of governance organs in year 2020:

Fourth week of April 2020	Eleventh Meeting of the Management and Program Sub-Committee	Seoul, Republic of Korea
Last Week of June 2020	Twelfth Meeting of the Management and Program Sub-Committee	If deemed necessary, virtually
Late October 2019	Ninth Session of the Assembly and Thirteenth Session of the Council (Joint Session)	Seoul, Republic of Korea

3. Scheduling the Eleventh Meeting of the MPSC in the middle of or late April will permit the MPSC to review the audited financial statements of GGGI, as well as to discuss the draft Annual Report and the planning direction of the Work Program and Budget 2021-2022. The discussion of the audited financial statements will include a meeting with GGGI's external auditor. The MPSC is formally required to provide a recommendation on the audited financial statements prior to its approval by the Council. If deemed necessary by the Members, the Twelfth Meeting of the MPSC could be held in the last week of June, and may be held virtually.
