- Article 3(a) of the Agreement on the Establishment of GGGI ("Establishment Agreement") defines a contributing member as "a Member of the GGGI that has provided a multi-year financial contribution of core funding of no less than 15 million USD over three years or 10 million USD over the first two years. The level and nature of contribution required to qualify as a contributing member shall be kept under review by the Assembly, and may be adjusted by the Assembly by consensus to support the growth of the GGGI over time"; Article 3(b) of the Establishment Agreement defines a participating

member as “a Member of the GGGI that is not a contributing member”.

- The differentiation of contributing and participating member relates solely to the composition of GGGI’s Council. In accordance with Article 8.2 of the Establishment Agreement, the Council is comprised of five contributing members elected by the Assembly; five participating members elected by the Assembly; five experts or non-state actors who can contribute substantially to the objectives of the GGGI, appointed by the Council; the host country, which shall have a permanent seat on the Council; and e. the Director-General without a voting right.
