**Decision on the Election of a Non-State Actor / Expert Member of Council  
for 2016-2017**

The Council,

*Recalling* Articles 2 and 4 of the Agreement on the Establishment of the Global Green Growth Institute (GGGI), regarding the objectives and activities of the GGGI;

*Recalling* Article 8(2)(c) of the Agreement on the Establishment of the GGGI regarding the function of the Council to appoint experts or non-state actors who can contribute substantially to the objectives of the GGGI, as members of the Council and Article 8(3) regarding the term limit of two years for these members;

*Recalling* Rule 3 of the Rules of the Procedure of the Council [[C/1/1](#)] adopted at the Inaugural Session of the Council on 23-24 October 2012, regarding the nomination and election of members to the Council;

*Recalling* the Criteria for Expert and Non-state Actor Members of the Council contained in Council Decision on Expert and Non-state Actors of the Council [[C/5/DC/4](#)] adopted at the Fifth Session of the Council on 19-20 June 2014;

*Recalling* the consultations with Members that identified five categories and communities of non-state actors and experts eligible to serve on the Council, namely: the business sector, cities/regions, the science community, finance/investors and the environment community;

*Recalling* previous Council Decisions regarding appointment of Expert and Non-state Actor Members to the Council, in 2015 [[C/6/DC/2](#)], in 2013 [[C/4/DC/5](#)] and in 2012 [[C/1/DC/2](#)];

*Defers the election* of a new non-state actor/expert to serve on the Council for the period 1 January 2016 through 31 December 2017 to allow for further consultation. The election of the non-state actor/expert to the Council will subsequently be taken by written procedure.
