Decision on the Election of Members to the Council for 2016-2017

The Assembly,

Recalling Articles 2 and 4 of the Agreement on the Establishment of the Global Green Growth Institute (GGGI), regarding the objectives and activities of the GGGI;

Recalling Article 7(5)(a) of the Agreement on the Establishment of the GGGI regarding the function of the Assembly to elect members of the Council taking into account the principle of rotation of members of the Council, and Article 8(2) regarding the composition of the Council;

Recalling Rule 54 of the Rules of the Procedure of the Assembly on the Terms of Office of members of the Council, as amended by Assembly Decision on the Terms of Office for Members of the Council and Subsidiary Organs of the Assembly [A/WRP/DC/2] adopted through written procedure on 28 November 2013;

Recalling previous Assembly Decisions regarding the election of members to the Council for 2015 [A/3/DC/3], 2014 [A/2/DC/3] and 2012-2013 [A/1/DC/3];

- 1. *Elects* Denmark and Norway as contributing members to serve on the Council for the period from 1 January 2016 through 31 December 2017.
- 2. *Defers the election* of two participating members to serve on the Council for the period 1 January 2016 through 31 December 2017 to allow for further consultation among participating members. The election of the two participating members to the Council will subsequently be taken by written procedure.
