CONTEXT/BACKGROUND

The Council is composed of up to 17 Members including five Contributing and five Participating Members elected by the Assembly, five Expert/Non-State Actors nominated and appointed by the Council, the Host Country with a permanent seat, and the Director-General without voting rights. Current and prospective Members of the Council are encouraged to volunteer as Members of the Management and Program Sub-Committee (MPSC) for 2024-2025.

SUMMARY

The following are the elections and appointments for the Council and MPSC that will take place on October 26, 2023, at the 12th Session of the Assembly and 16th Session of the Council:

- a. The Assembly will elect five Contributing Members to serve on the Council for 2024-2025
- b. The Council will appoint up to three Expert/Non-State Actors to serve on the Council for 2024-2025
- c. The Council will elect Members of the MPSC for 2024-2025

Ahead of the Joint Session on October 26, 2023:

- a. Contributing Members of GGGI are invited to express interest to serve on the Council in 2024-2025
- b. GGGI Member States are invited to nominate Experts/Non-State Actors to become a Member of the Council for 2024-2025
- c. Current and prospective Members of the Council are invited to express interest to serve on the MPSC for 2024-2025

Member States are invited to express interest to serve on the governance organs of GGGI or make nominations for Expert/Non-State Actor Members of the Council, in written form at <u>governance@gggi.org</u> by October 20, 2023.

Election of Members to Governance Organs

Introduction

- The purpose of this Note is to provide Members of the Assembly and the Council information on the election of Members to the Council and the Management and Program Sub-Committee (MPSC) for the term of 2024-2025. The elections will take place at the 12th Session of the Assembly and 16th Session of the Council (Joint Session) on October 26, 2023.
 - a. Members of the Assembly will elect up to five Contributing Members of the Council for the period of 2024-2025.
 - The five Participating Member seats on the Council are currently serving terms of 2023-2024 and do not need to be re-elected this year. The next election for Participating Member seats for the term of 2025-2026 will take place at the Assembly and Council Joint Session in October 2024.
 - b. Members of the Council will nominate and appoint up to three Expert/Non-State Actor Members of the Council for the period of 2024-2025.
 - c. Members of the Council will elect Members of the Management and Program Sub-Committee for the period of 2024-2025.
- 2. Member States are invited to express interest to serve on the governance organs of GGGI and to make nominations for Expert/Non-State Actor Members of the Council in written form to governance@gggi.org by October 20, 2023.

Election of Council Members

Composition of the Council

- 3. Article 8(2) of the <u>Establishment Agreement</u> states that "The Council shall consist of no more than 17 members, as follows:
 - a. five contributing members elected by the Assembly;
 - b. five participating members elected by the Assembly;
 - c. five experts or non-state actors who can contribute substantially to the objectives of the GGGI, appointed by the Council;
 - d. the host country, which shall have a permanent seat on the Council; and
 - e. the Director-General without a voting right."
- 4. Rule 49(b) of the Rules of Procedure of the Assembly [<u>A/4/DC/2/FINAL</u>] states "The term of office of each Member of the Council shall begin on January 1 of the coming calendar year after such Member's election to the Council and shall end on December 31 of the second year of the term of appointment."
- Rule 49(c) of the Rules of Procedure of the Assembly [<u>A/4/DC/2/FINAL</u>] states that "Contributing and Participating Members of the Council shall be eligible in principle to serve up to two (2) consecutive terms."

Electing Contributing Members of the Council

A/2023/11-C/2023/11

- 6. <u>Members of the Assembly will elect five Contributing Members of the Council for the period of</u> 2024-2025. Contributing Members of GGGI are invited to serve on the Council.
- 7. Article 3(a) of the <u>Establishment Agreement</u> defines Contributing Member as "a Member of the GGGI that has provided a multi-year financial contribution of core funding of no less than 15 million USD over three years or 10 million USD over the first two years."
- 8. On December 31, 2023, the current terms of three Contributing Members will end, namely:
 - a. Indonesia
 - b. Norway
 - c. United Arab Emirates

With two of the five Contributing Member seats currently vacant, there will be a total of five Contributing Member seats on the Council to be elected.

- 9. The Contributing Members that will be available to serve as on the Council for the 2024-2025 term are:
 - a. Australia
 - b. Denmark
 - c. Indonesia
 - d. Norway
 - e. Qatar
 - f. United Kingdom

Among the Contributing Members whose terms will end on December 31, 2023, the United Arab Emirates will have served two consecutive terms on the Council.

Appointing Expert/Non-State Actor Members of the Council

- 10. <u>Members of the Council will appoint up to three Expert/Non-State Actor Members of the Council</u> for the term of January 1, 2024-December 31, 2025. Ahead of the Joint Session, Member States of <u>GGGI are invited to make nominations.</u>
- 11. Expert means individuals who can contribute substantially to the objectives of GGGI, and Non-State Actor means international and intergovernmental organizations, private companies, research institutes and non-governmental organizations that can contribute substantially to the objectives of GGGI.
- 12. Rule 5 of the Rules of Procedure of the Council [C/8/DC/2/FINAL] states,
 - a. Prospective Expert/Non-State Actor Members of the Council may be nominated by a Member of the Council, including the Director-General, and shall be appointed by the Council in accordance with Article 8.2(c) of the Agreement; and
 - b. Experts/Non-State Actor Members are in principle eligible to serve up to two consecutive terms, unless otherwise decided by the Council.
- 13. The criteria to nominate Expert/Non-State Actor Members of the Council is that the candidate shall:
 - a. Be supportive of the objectives presented in Article 2 of GGGI's Establishment Agreement¹.

¹ "The GGGI shall promote sustainable development of developing and emerging countries, including the least developed countries, by: (a) supporting and diffusing a new paradigm of economic growth: green growth, which is a balanced advance of economic growth and environmental sustainability; (b) targeting key aspects of economic performance and resilience,

- b. Be in a position at the time of selection that is consistent with the term "expert or non-state actor" (i.e., not hold a government position or be a representative of any state).
- c. Be a recognized authority in a field of direct relevance to the accomplishment of the objectives of GGGI, and originate from one of the five categories: business sector, cities/regions, science community, finance/investor community, and environment community.
- d. Have the capacity to present a viewpoint that enhances the breadth and depth of debate in the Council in executing its responsibilities as articulated in the Agreement.
- e. Be willing and able to serve on the Council and participate in sessions of the Council and Sub-Committee meetings or other meetings of governance organs as may be necessary.
- 14. On December 31, 2023, the current terms of three Expert/Non-State Actor Members will end:
 - a. Mr. Ban Ki-moon²
 - b. Ms. Maria Kiwanuka
 - c. Ms. Pepukaye Bardouille
- 15. With one of the five Expert/Non-State Actor seats currently vacant, there will be a total of four Expert/Non-State Actor seats on the Council to be appointed. Mr. Boonam Shin's Council's term will end on December 31, 2024. For an overview of the terms of each Expert/Non-State Actor of the Council in 2012-2024 see Annex 4.
- 16. Annex 4 shows the list of all Expert/Non-State Actor Members of the Council in 2012-2023.

Election of the Management and Program Sub-Committee of the Council

- 17. <u>Members that are currently on the Council until the end of 2024, and prospective Members of the</u> <u>Council (Members that express interest to serve on the Council in 2024-2025), are invited to serve</u> <u>on the MPSC for the term of 2024-2025.</u>
- 18. The MPSC shall consist of those Members of the Council that express interest in serving on the MPSC. Members may express their interest in serving on the MPSC at the time they are expressing their interest in serving on the Council. The MPSC shall be comprised of at least one Contributing Member, one Participating Member, and one Expert/Non-State Actor Member of the Council, unless the Council decides otherwise.³
- 19. MPSC Members shall serve for a term of two years coinciding with their terms as a Member of the Council. They may serve an unlimited number of consecutive terms on the MPSC while a Member of the Council. Members shall cease to be a Member of the MPSC at the time their term on the Council ends.⁴

Method of Elections and Appointment

- 20. The <u>Establishment Agreement</u> mandates that Members "shall make every effort to reach a decision by consensus," and all elections and appointments have customarily taken place in a form of consensus among Members.
- If consensus cannot be reached, voting will take place in accordance with the Rules of Procedure of the Assembly [<u>A/4/DC/2/FINAL</u>] and Rules of Procedure of the Council [<u>C/8/DC/2/FINAL</u>]. The relevant rules on voting procedure can be found in Annex 6.
